## A BILL FOR AN ACT

To further amend Public Law No. 9-079, by amending section 3 to modify the use of funds appropriated therein for certain airports in the State of Chuuk, and by further amending section 4, as amended by Public Laws Nos. 9-110 and 9-152, to extend the lapse date to September 30, 1999, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 9-079 is hereby
2	amended to read as follows:
3	"Section 3. The sum of \$100,000, or so much thereof
4	as may be necessary, is hereby appropriated from the
5	General Fund of the Federated States of Micronesia
G	for the fiscal year ending September 30, 1996, for
7	the purpose of repairing. Apply improving and
8	providing for other needs of the airports on the
9	islands of Ta and Houk, to be apportioned as
10	follows:
1.1	(1) Houk airport\$ 50,000
12	(2) Ta airport 50,000"
13	Section 2. Section 4 of Public Law No. 9-079, as
14	amended by Public Laws Nos. 9-110 and 9-152, is here.
15	further amended to read as follows:
16	"Section 4. All funds appropriated by this act
17	shall be allotted, managed, administered, and
18	accounted for in accordance with applicable law,
19	including but not limited to the Financial
20	Management Act of 1979. The allottee of the funds
21	appropriated by subsection (1) of section 3 of this
22	act shall be the Northwest Islands Project
23	Coordinator. The allottee of the funds appropriated
24	by subsection (2) of section 3 of this act shall be
25	the Mortlocks Development Authority. The allottee

1	of all other funds appropriated by this act shall be
2	the Secretary of the Department of Transportation
3	and Communication of the Federated States of
4	Micronesia or the Secretary's designee. The
5	allottees shall be responsible for ensuring that
6	these funds, or so much thereof as may be necessary,
7	are used solely for the purpose specified in this
8	act, and that no obligations are incurred in excess
9	of the sum appropriated. The authority of the
10	allottee to obligate funds appropriated by this act
11	shall lapse as of September 30, 1998 1999."
12	Section 3. This act shall become law upon approval by
1.3	the President of the Federated States of Micronesia or upon
1.4	its becoming law without such approval.
