A BILL FOR AN ACT

To further amend Public Law No. 9-100, as amended, by further amending section 5, as amended by Public Laws Nos. 9-104, 9-137, 9-151, 10-20, 10-44 and 10-73, for the purpose of changing allottee of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 5 of Public Law No. 9-100, as amended
by Public Laws Nos. 9-104, 9-137, 9-151, 10-20, 10-44, and 103 73, is hereby further amended to read as follows:

4 "Section 5. All funds appropriated by this act shall be allotted, managed, administered, and 5 accounted for in accordance with applicable law, 6 including, but not limited to, the Financial 7 Management Act of 1979. The allottee of the funds 8 9 appropriated under subsection (1) of section 1 of this act shall be the Governor of the State of 10 Chuuk. The allottee of the funds appropriated under 11 subsection (2)(a), (2)(b), (2)(c) and (2)(d) of 12 section 1 of this act shall be the Toleisom 13 Authority. The allottees of the funds appropriated 14 under subsection (2)(e) and (2)(f), except for funds 15 appropriated under subsection (2)(e)(iv), of section 16 1 of this act shall be the mayors of the respective 17 municipalities. The allottee of the funds 18 appropriated under subsection (2)(e)(iv), (2)(g), 19 (2)(h) and (2)(i) of section 1 of this act shall be 20 the mayor of Polle Municipality. The allottee of 21 the funds appropriated under subsection (3) of 22 section 1 of this act shall be the Southern Namoneas 23 Development Authority. The allottee of the funds 24 appropriated under subsections (4) and (8) of 25

section 1 of this act shall be the Northern Namoneas Development Authority. The allottee of the funds appropriated under subsection (5) of section 1 of this act shall be the Mortlock Development Authority. The allottee of the funds appropriated under subsection (6)(a) of section 1 of this act shall be the Halls Project Coordinator. allottee of the funds appropriated under subsection (6)(b) of section 1 of this act shall be the Weito Project Coordinator. The allottee of the funds appropriated under subsections (6)(c) and (6)(d) of section 1 of this act shall be the Pattiw Development Authority. The allottee of the funds appropriated under subsection (6)(e) of section 1 of this act shall be the Northwest Islands Project Coordinator. The allottee of the funds appropriated under subsection (7) of section 1 and subsection (2) of section 4 of this act shall be the Speaker of the Congress of the Federated States of Micronesia or the Speaker's designee. The allottee of the funds appropriated under subsection (2) of section 2 of this act shall be the Chairman of the Kosrae Utilities Authority, and the allottee of the funds appropriated under subsection (9) of section 2 of this act shall be the Governor of the State of

1 The allottee of the funds appropriated 2 under subsection (1)(a)(i) of section 3 of this act 3 shall be the Mayor of Kolonia Town. The allottee of the funds appropriated under subsections 4 5 (1)(a)(ii)a), (1)(a)(ii)b), and (1)(a)(ii)c) of 6 section 3 of this act shall be the Pohnpei 7 Transportation Authority. The allottee of the funds appropriated under subsection (1)(a)(ii)d) of 8 section 3 of this act shall be the Chief Magistrate 9 of Sokehs Municipality. The allottee of the funds 10 appropriated under subsection (1)(b) of section 3 of 11 12 this act shall be the Vice President of the Federated States of Micronesia or the Vice 13 President's designee. The allottee of the funds 14 15 appropriated under subsection (2)(a) and (2)(b) of section 3 of this act shall be the Pohnpei Visitor's 16 17 Bureau. The allottee of the funds appropriated 18 under subsections (1) and (3) of section 4 of this act shall be the Governor of the State of Yap. The 19 20 allottee of all other funds appropriated by this act shall be the President of the Federated States of 21 Micronesia or the President's designee. The 22 allottees shall be responsible for ensuring that 23 24 these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this 25

1	act, and that no obligations are incurred in excess
2	of the sum appropriated. The allottees of the funds
3	appropriated under subsection (1)(a) and (1)(b) of
4	section 3 of this act shall not obligate any funds
5	appropriated therein without first consulting with
6	the member of the Pohnpei Delegation to Congress
7	representing the Election District to which the
8	funds are apportioned. The allottees of funds
9	appropriated under subsection (1)(a) of section 3 of
10	this act shall not obligate or expend any funds
11	apportioned under said subsection for travel. The
12	authority of the allottees to obligate funds
13	appropriated by this act shall not lapse."
14	Section 2. This act shall become law upon approval by the
15	President of the Federated States of Micronesia or upon its
16	becoming law without such approval.
