

## TENTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

FOURTH SPECIAL SESSION, 1999

CONGRESSIONAL BILL NO. 10-374, C.D.1

## AN ACT

To further amend Public Law No. 6-28, as amended, by further amending section 1, as amended by Public Laws Nos. 6-66 and 7-103, and by further amending section 4, as amended by Public Laws Nos. 6-66, 8-22, 9-006, 9-111 and 10-134, for the purpose of permitting appropriated funds for the use of the Hall and Mortlock Islands to be used for social and economic purposes within the Hall and Mortlock Islands, and to change the allottee, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Section 1 of Public Law No. 6-28, as amended by

- "Section 4. Allotment and management of funds and lapse 16

- (1) All funds appropriated by this act shall be 18 allotted, managed, administered and accounted for in 19 accordance with applicable law, including, but not 20 limited to, the Financial Management Act of 1979. The 21

1	section 2 of this act shall be the Pohnpei Port
2	Authority. The allottee of the funds provided under
3	subsection (2)(b) of section 2 of this act shall be the
4	Mortlocks Project Coordinator. The allottees shall be
5	responsible for ensuring that these funds, or so much
6	thereof as may be necessary, are used solely for the
7	purpose specified in this act, and that no obligations
8	are incurred in excess of the sum appropriated.
9	(2) The authority of the allottee to obligate funds
10	appropriated by this act shall not lapse."
11	Section 3. This act shall become law upon approval by the
12	President of the Federated States of Micronesia or upon its becoming
13	law without such approval.
