A BILL FOR AN ACT

To further amend title 53 of the Code of the Federated States of Micronesia, as amended, by further amending section 701, as amended by Public Law No. 5-120, to permit Board members whose terms expire after January 1, 1999, but whose replacements have not been nominated or confirmed, to continue to serve until their replacements have been confirmed by Congress; to specify that the Social Security Administrator shall be a non-voting ex officio member of the Board; and for other

- purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 701 of title 53 of the Code of the Federated States of Micronesia, as amended by Public Law No. 5-120, is hereby further amended to read as follows: 4 "Section 701. [Board-Established-Composition-5 Compensation] The Board. (1) Establishment and composition. There is created a 6 Federated States of Micronesia Social Security Board of five members nominated by the President and confirmed by 8 the Congress of the Federated States of Micronesia to 9 operate the Social Security Program authorized by this 10 subtitle. 11 (2) Representation. Nominations to the Board shall 12 take into account the need to have adequate geographical 13 representation and to have representatives from public 14 and private sector employers and employees. 15

 - (3) Term of Office. Members of the Board shall serve three-year terms, provided that a member whose term expires after January 1, 1999, and whose replacement has not been nominated and confirmed by the Congress at the date of expiration of the term may continue to serve until his or her replacement has been confirmed by Congress and is seated on the Board.
- (4) Organization. [and t] The Board shall provide for 23 its own organization and procedures. 24
- (5) <u>Vacancies</u>. Any vacancies on the Board shall be 25

2	for one year or less, it shall be filled by appointment
3	by the President; otherwise vacancies shall be filled by
4	nomination by the President and confirmation by the
5	Congress.
6	(6) The Administrator. The Social Security
7	Administrator shall be [an] a non-voting ex officio
8	member of the Board.
9	(7) Remuneration. Members of the Board who are not
10	State or National Government employees shall be paid at
11	the rate of \$30 per day and necessary travel expenses
12	when actually attending meetings of the Board."
13	Section 2. This act shall become law upon approval by the
14	President of the Federated States of Micronesia or upon its becoming
15	law without such approval.
