## A BILL FOR AN ACT

To further amend Public Law No. 6-74, as amended, by further amending section 5, as amended by Public Laws Nos. 6-101, 7-72, 8-152, 9-061, 9-141, and 10-105, to extend the lapse date to September 30, 1999, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 5 of Public Law No. 6-74, as amended 1 2 by Public Laws Nos. 6-101, 7-72, 8-152, 9-061, 9-141, and 10-3 105, is hereby further amended to read as follows: "Section 5. Allotment and management of funds and 5 lapse date. (1) All funds appropriated by this act shall be 7 allotted, managed, administered, and accounted for in accordance with applicable law, including, but not 8 limited to, the Financial Management Act of 1979. 9 The allottee of the funds appropriated under 10 paragraphs (a), (b), (c) and (d) of subsection (1) of 11 12 section 1 of this act shall be the Chief Magistrate of the Sokehs Municipal Government. The allottee of 13 14 the funds appropriated under subsection (2) of section 1 of this act shall be the Kolonia Town 15 Mayor. The allottee of the funds appropriated under 16 17 subsection (3) of section 1 of this act shall be the Luhkenkolwof of Sapwuahfik. The allottee of the 18 funds appropriated under subsection (4) of section 1 19 of this act shall be the Chief Magistrate of the 20 Nukuoro Municipal Government. The allottee of the 21 22 funds appropriated under subsection (5) of section 1 23 of this act shall be the Chief Magistrate of the 24 Kapingamarangi Municipal Government. The allottee of the funds appropriated under subsections (6) and (7) 25

of section 1 of this act shall be the Chief 1 2 Magistrate of the Sokehs Municipal Government. allottee of the funds appropriated under subsections 3 4 (1) and (2) of section 2 and paragraph (3)(a) of section 2 of this act shall be the Menin Keder 5 6 Lapalap of the Madolenihmw Municipal Government. 7 allottee of the funds appropriated under paragraph (3) (b) of section 2 shall be the Madolenihmw 8 9 Municipal Government. The allottee of the funds appropriated under subsections (4) and (5)(a) of 10 section 2 and paragraph (6)(a) of section 2 of this 11 12 act shall be the Luhkenmenlap of the Kitti Municipal Government. The allottee of the funds appropriated 13 14 under paragraph (5)(b) of section 2 of this act shall be the President of the Federated States of 15 16 Micronesia. The allottee of the funds appropriated under paragraph (6)(b) of section 2 of this act shall 17 18 be the Kitti Municipal Government. The allottees of 19 the funds appropriated under subsections (1), (2), 20 (4) and (5) of section 2 of this act and paragraphs (3)(a) and (6)(a) of section 2 of this act shall 21 submit detailed funds status and project status 22 reports to the Congress of the Federated States of 23 24 Micronesia at the beginning of each quarter of each 25 fiscal year. The allottee of the funds appropriated

1 under paragraphs (e), (f), (g), (h) and (i) of subsection (1) of section 1; paragraphs (b), (c), 3 (d), (e) and (f) of subsection (1) of section 3; and section 4 of this act shall be the President of the Federated States of Micronesia or the President's 5 6 designee; PROVIDED, however, that the funds allotted 7 under subsection (6) of section 1 of this act shall not be allotted before October 1, 1990. The allottee 8 of the funds appropriated under subsection (1)(a) of 9 10 section 3 of this act shall be the Pohnpei 11 Transportation Authority. The allottee of the funds appropriated under subsection (2) of section 3 of 12 13 this act shall be the Coconut Development Authority. 14 The allottees shall be responsible for ensuring that these funds, or so much thereof as may be necessary, 15 are used solely for the purpose specified in this 16 act, and that no obligations are incurred in excess 17 18 of the sum appropriated. 19 (2) The authority of the allottee to obligate 20 funds appropriated by this act shall lapse as of  $[\underline{May}]$ 21 31]September 30, 1999." 22 23
