

CONGRESSIONAL BILL NO. 15-79, C.D.1

PUBLIC LAW No. 15-25

AN ACT

To appropriate from the General Fund of the Federated States of Micronesia, a sum of \$366,255 realized from the 20% restricted funds previously allocated for Health and Education in Chuuk State for the purpose of funding Public Projects in Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$366,255 realized from the 20%
2 restricted funds previously allocated for Health and Education in
3 Chuuk State and now lapsed into the general fund, is hereby
4 appropriated from the General Fund of the Federated States of
5 Micronesia for the fiscal year ending September 30, 2008 for the
6 purpose of funding Public Projects in Chuuk State, and shall be
7 apportioned as follow:

8	1. Chuuk Public Utility Corporation.....	\$ 150,000
9	2. Chuuk State Health Care Plan.....	216,255

10 Section 2. Allotment and management of funds and lapse date.


11 All funds appropriated by this act shall be allotted, managed,
12 administered and accounted for in accordance with applicable laws,
13 including, but not limited to, the Financial Management Act of
14 1979. The allottee shall be responsible for ensuring that these
15 funds, or so much thereof as may be necessary, are used solely for
16 the purpose specified in this act, and that no obligations are
17 incurred in excess of the sum appropriated. The allottee of the
18 funds appropriated under this act shall be the President of the

1 Federated States of Micronesia. The authority of the allottee to
2 obligate funds appropriated by this act shall lapse on September
3 30, 2008."

4 Section 3. This act shall become law upon approval by the
5 President of the Federated States of Micronesia or upon its
6 becoming law without such approval.
