I am pleased to inform you that I have designated the following Congressional Act as Public Law No. 15-53:

Congressional Act No. 15-56, "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 14-84, AS AMENDED, BY AMENDING SECTIONS 4 AND 9 THEREOF, TO CHANGE THE USE AND LAPSE DATE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS IN THE STATE OF YAP, AND FOR OTHER PURPOSES."

Be advised there is a remaining fund balance of \$3,476.55 yet to be expended under Section 4 (vii) of Public Law No. 14-84, after the transfer of \$15,250 for the new line item "Tigigin Men's House". In other words, the fund balance for Section 4 (vii) of Public Law No. 14-84, as amended, as of September 24, 2008 is \$18,726.55, not \$15,250.

AN ACT

To further amend Public Law No. 14-84, as amended, by amending sections 4 and 9 thereof, to change the use and lapse date of certain funds previously appropriated to fund public projects and social programs in the State of Yap, and for other purposes.

1	Section 1. Section 4 of Public Law No. 14-84, as amended by
2	Public Laws Nos. 14-96, 14-103 and 14-108, is hereby further

6	of Section 1 of this Act shall be the Governor of the
7	State of Kosrae. The allottee of the funds appropriated
8	in Sections 2, 3, and 4 of this Act shall be the Chuuk
9	State Commission on Improvement Project. The allottee
10	shall be responsible for ensuring that these funds, or
11	so much thereof as may be necessary, are used solely for
12	the purpose specified in this act, and that no
13	obligations are incurred in excess of the sum
14	appropriated. The authority of the allottee to obligate
15	funds appropriated by this Act shall lapse as of
16	September 30, 2009."
