#### AN ACT

To further amend Public Law No. 11-27, as amended, by amending section 3 thereof, to change the use of certain funds previously appropriated therein for the State of Yap, and for other purposes.

#### BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
