Dear Speaker Figir:


Transmitted herewith is the following Congressional Act, which has become Public Law No. 16-28 without my signature.

PUBLIC LAW No. 16-28

AN ACT

To amend Public Law No. 15-31, as amended by Public Laws Nos. 15-54, 15-79, 16-2 and 16-21, by further amending Section 1 thereof, to change the use of certain funds previously appropriated therein for the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 15-31, as amended by
2 Public Laws Nos. 15-54, 15-79, 16-02 and 16-21, is hereby further
3 amended to read as follows:

4 "Section 1. The sum of \$342,000 is hereby appropriated
5 from the General Fund of the Federated States of
6 Micronesia for the fiscal year ending September 30, 2008
7 for the purpose of funding public projects in the State
8 of Pohnpei, and is apportioned as follows:

9	(1) Kapingamarangi Airport.....	\$ 47,295
10	(2) Kolonia Town Court House.....	42,000
11	(3) Upper Ipwal to Upper Roie	
12	Road construction	96,080
13	(4) Tomara Road concrete completion.....	10,000
14	(5) Nanmadap Road concrete completion....	5,000
15	(6) Students' financial assistance (COM-FSM)	4,000
16	(7) Project management.....	43,920
17	(8) Kapingamarangi Bridge repair.....	24,530
18	(9) Construction related equipment

3 Section 2. This act shall become law upon approval by the
 4 President of the Federated States of Micronesia or upon its
