I am pleased to inform the Sixteenth Congress that I have signed to become Public Law No. 16-36 the enclosed Congressional Act No. 16-36, entitled,

"AN ACT TO FURTHER AMEND SECTION 321 OF TITLE 54 OF THE CODE OF THE FEDERATED STATES OF MICRONESIA, AS AMENDED BY PUBLIC LAW NO. 13-71, IN ORDER TO DECREASE THE TAX RATE IMPOSED ON MAJOR CORPORATIONS, AND FOR OTHER PURPOSES."



PUBLIC LAW No. 16-36

AN ACT

To further amend section 321 of title 54 of the Code of the Federated States of Micronesia, as amended by Public Law. No. 13-71, in order to decrease the tax rate imposed on major corporations, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 321 of title 54 of the Code of the
- 2 Federated States of Micronesia, as enacted by Public Law No.
- 3 13-71, is hereby amended to read as follows:

4 "Section 321. <u>Tax imposed</u>. A tax at the rate of

5 twenty-one percent (21 percent) is hereby imposed for

6 each taxable year on the taxable income of every major

7 corporation."
