I take this opportunity to thank you and all the honorable members of Congress for approving Congressional Act No. 16-5, entitled:

"AN ACT TO APPROPRIATE THE SUM OF \$60,000, FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR 2009, FOR THE PURPOSE OF FUNDING THE NATIONAL SPECIAL ELECTION TO FILL THE VACANT POHNPEI AT-LARGE SEAT TO TAKE PLACE PURSUANT TO LAW, AND FOR OTHER PURPOSES."

CONGRESSIONAL BILL NO. 16-33

PUBLIC LAW No. 16-5

AN ACT

To appropriate the sum of \$60,000 from the General Fund of the Federated States of Micronesia for the fiscal year 2009, for the purpose of funding the national special election to fill the vacant Pohnpei at-large seat to take place pursuant to law, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Appropriation. There is hereby appropriated from
- 2 the General Fund of the Federated States of Micronesia for the
- 3 fiscal year 2009 the sum of \$60,000, or so much thereof as may be
- 4 necessary, for the exclusive purpose of funding the national
- 5 special election to fill the vacant Pohnpei at-large seat
- 6 scheduled to take place pursuant to law. The funds appropriated
- 7 in this act shall not be used to fund previous election
- 8 expenditures.
- 9 Section 2. Reprogramming. Funds appropriated in accordance
- 10 with this act are not to be subject to reprogramming.
- 11 Section 3. Allottee. The allottee of the funds appropriated
- 12 by this act shall be the President of the Federated States of
- 13 Micronesia.
- 14 Section 4. Allotment and management of funds and lapse date.
- 15 All funds appropriated by this act shall be allotted, managed,
- 16 administered and accounted for in accordance with applicable law,
- 17 including, but not limited, the Financial Management Act of 1979.
- 18 The allottee shall be responsible for ensuring that these funds,
- 19 or so much thereof as may be necessary, are used solely for the
