I am pleased to inform Congress that I have signed the following congressional act to become Public Law No. 17-55:

Congressional Act No. 17-54, "AN ACT TO FURTHER AMEND TITLE 3 OF THE CODE OF THE FEDERATED STATES OF MICRONESIA, AS AMENDED, BY AMENDING SECTION 103 THEREOF, TO CREATE A POSITION OF ASSISTANT CHIEF CLERK OF CONGRESS, TO MAKE A TECHNICAL AMENDMENT TO THE TITLE OF THE POSITION OF THE CHIEF CLERK OF CONGRESS, AND FOR OTHER PURPOSES."

While there is no committee report that indicates the rationale behind the passage of the act, what is clear is corresponding increase in the operational budget of Congress as a result of newly created position. I support this initiative if it achieves more efficiency and productivity in legislative works.

## PUBLIC LAW NO. 17-55

#### AN ACT

To further amend title 3 of the Code of the Federated States of Micronesia, as amended, by amending section 103 thereof, to create a position of Assistant Chief Clerk of Congress, to make a technical amendment to the title of the position of the Chief Clerk of Congress, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 103 of title 3 of the Code of the 2 Federated States of Micronesia is hereby amended to read as 3 follows: 4 "Section 103. Immediate offices. There shall be the following offices which shall be 5 6 under the direct supervision of the Presiding 7 Officer: 8 (1) Office of the Chief Clerk and assistant Chief 9 Clerk; and 10 (2) Public Information Office." 11 12 13 14 15 16
