
I am writing to inform you that I have designated the following Congressional Act as Public Law No. 18 -24:

**Congressional Act No. 18-25** – TO APPROPRIATE THE SUM OF \$225,000 FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR ENDING SEPTMBER 30, 2014, FOR THE PURPOSE OF HUMANITARIAN RELIEF EFFORTS FOR VICTIMS OF TYPHOON HAIYAN IN THE REPUBLIC OF THE PHILLIPINES, THE REPUBLIC OF PALAU, THE STATE OF YAP AND THE SOCIALIST REPUBLIC OF VIETNAM, AND FOR OTHER PURPOSES.”

I am pleased that Congress has taken the initiative to appropriate funding for humanitarian assistance to the affected neighboring areas as a result of typhoon Haiyan which has swept through these areas and has left immeasurable impact and devastation to the essential services, property and life.

**PUBLIC LAW No. 18-24**

---

AN ACT

To appropriate the sum of \$225,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, for the purpose of humanitarian relief efforts for victims of Typhoon Haiyan in the Republic of the Philippines, the Republic of Palau, the State of Yap and the Socialist Republic of Vietnam, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. The sum of \$225,000 is hereby appropriated from  
2 the General Fund of the Federated States of Micronesia for the  
3 fiscal year ending September 30, 2014. The funds appropriated  
4 under this section shall be used to fund humanitarian relief  
5 efforts for victims of Typhoon Haiyan in the Republic of the  
6 Philippines, the Republic of Palau, the State of Yap and the  
7 Socialist Republic of Vietnam.

8	a) Republic of the Philippines .....	\$ 100,000
9	b) Republic of Palau .....	50,000
10	c) State of Yap .....	50,000
11	d) Socialist Republic of Vietnam .....	25,000


12       Section 2. Allotment and management of funds and lapse date.

13 All funds appropriated by this act shall be allotted, managed,  
14 administered, and accounted for in accordance with applicable law,  
15 including but not limited to, the Financial Management Act of  
16 1979. The allottee of the funds appropriated under this act shall  
17 be the President of the Federated States of Micronesia. The  
18 allottee of the funds appropriated herein shall be responsible for

1 ensuring that these funds, or so much thereof as may be necessary,  
2 are used solely for the purpose specified herein, and shall report  
3 back to Congress on the status of these funds no later than  
4 September 30, 2014. The authority of the allottee to obligate  
5 such funds shall lapse on September 30, 2014.

6 Section 3. This act shall become law upon approval by the  
7 President of the Federated States of Micronesia or upon its  
8 becoming law with such approval.
