

CONGRESSIONAL BILL NO. 18-195

PUBLIC LAW No. 18-77

AN ACT

To further amend Public Law No. 16-58, as amended by Public Laws Nos. 16-64, 16-72, 17-08, 17-11, 17-20, 17-35 and 17-41, by amending section 4 thereof, to modify the use of certain funds previously appropriated therein, to fund public projects and social programs in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 16-58, as amended
2 by Public Laws Nos. 16-64, 16-72, 17-11, 17-20 and 17-35, is
3 hereby further amended to read as follows:

4 "Section 4. Of the sum of \$1,005,000 appropriated by
5 this act, \$310,000 is apportioned for Pohnpei State for
6 public projects and social programs.
