Dear Speaker Halbert:

I transmit the following congressional acts, which I have signed into laws as follows:

Public Law No. 18-08, Congressional Act No. 18-07, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 14-140, AS AMENDED BY PUBLIC LAWS NOS. 15-01 AND 15-04, BY ADDING A NEW SECTION 14, FOR THE PURPOSE OF FORGIVING THE REMAINING BALANCE OF THE RECOVERY LOAN ASSISTANCE EXTENDED TO KOSRAE STATE, AND FOR OTHER PURPOSES."

Public Law No.18-09, Congressional Act no. 18-08, entitled: "AN ACT TO AMEND PUBLIC LAW NO. 10-31 BY ADDING A NEW SECTION 9, FOR THE PURPOSE OF FORGIVING THE REMAINING BALANCE OF THE RECOVERY LOAN ASSISTANCE EXTENDED TO CHUUK STATE, AND FOR OTHER PURPOSES."

Having signed the foregoing congressional acts into public laws, I take this opportunity to thank you for passing these acts. At the same time, I also wish to express my disappointment because of our failure to institute and enforce the agreed-upon fiscal reforms for Chuuk State and Kosrae State before forgiving these loans. An automatic forgiveness of loans to the States disregards the conditions by which loan assistance was made in the first place.

In an MOU with the National Government, Chuuk State agreed to balance its budget beginning in FY 2008, meaning that its annual expenditures would not exceed gross revenue for a given fiscal year. Conditions of the MOU included: (1) restructuring the executive and legislative branches of the state government within five years through a shift from a bicameral to a unicameral legislature in order to produce a savings of approximately \$1.0 million; (2) installment of a public auditor; and, (3) hiring a special prosecutor.


These conditions have not been fulfilled. For Kosrae State, similar financial reforms were discussed; however, its cash flow has not improved. The two States' outstanding debts may be erased from their respective books through these acts, but the needed reforms will remain without being resolved.

I wish to note that Congressional Act No. 18-08 fails to consider another loan made to Chuuk State pursuant to Public Law No. 17-68 in the amount of \$978,860 for FEMA reimbursement. There is a lack of intention for Chuuk State to repay the loan for FEMA, as evidenced by their failure to sign a promissory note.

I respectfully urge that Congress to seriously consider forgiving this loan as well.



CONGRESSIONAL BILL NO. 18-34

PUBLIC LAW No. 18-08

AN ACT

To further amend Public Law No. 14-104, as amended by Public Laws Nos. 15-01 and 15-04, by adding a new section 14, for the purpose of forgiving the remaining balance of the recovery loan assistance extended to Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Purpose. The purpose of this act is to absolve
2 Kosrae State from repayment of the loan provided them by the
3 National Government in 2006. Through Public Law No. 14-104, the
4 National Government provided loan assistance to Kosrae State in
5 the amount of \$1,500,000 to alleviate the financial crisis the
6 state was then facing. The balance currently outstanding is
7 \$1,310,000. Due to the current financial position of the State of
8 Kosrae, it is prudent the National Government extend further
9 assistance by forgiving the loan balance of \$1,310,000.

10 Section 2. Public Law No. 14-104, as amended by Public Laws
11 Nos. 15-01 and 15-04, is hereby further amended by adding a new
12 section 14 to read as follows:

13 "Section 14. The balance of the loan assistance
14 provided to Kosrae State through Public Law No. 14-104,
15 as amended by Pubic Laws Nos. 15-01 and 15-04, is hereby
16 forgiven; the State of Kosrae is hereby absolved from
17 its remaining obligations under the loan agreement
18 entered into pursuant to section 8 of Public Law
19 No. 14-104."

PUBLIC LAW No. 18-08

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.


