
I am transmitting the following Congressional Act, which I signed into Public Law No. 19-48, as follows:

Congressional Act No. 19-49, entitled: "An act to further amend Public Law No. 18-35, as amended by Public Laws Nos. 18-49, 18-61, 18-63, 18-78, 18-98, 18-111, 18-123, 19-06, 19-12 and 19-40 by amending sections 2 and 4 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs for the people of the States of Yap and Pohnpei, and for other purposes."

As indicated on its title, the act changes certain funds for public projects and social programs for the people of the States of Yap and Pohnpei. The act does not involve any additional funding for public projects and social programs.

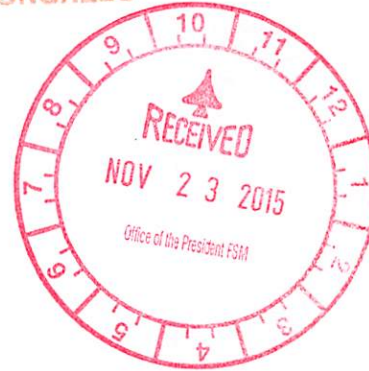


