

PUBLIC LAW No. 19-64

AN ACT

To appropriate the sum of \$3,050,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2016, for the purpose of funding public projects and social programs in the states of Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Purpose. The sum of \$3,050,000, or so much
2 thereof as may be necessary, is hereby appropriated from the
3 General Fund of the Federated States of Micronesia for the fiscal
4 year ending September 30, 2016, for the purpose of funding public
5 projects and social programs in the states of Kosrae and Pohnpei.
6 The funds appropriated under this section shall be apportioned as
7 follows:

11 Section 2. Allotment and management of funds and lapse
12 date. All funds appropriated by this act shall be allotted,
13 managed, administered and accounted for in accordance with
14 applicable laws, including, but not limited to, the Financial
15 Management Act of 1979. The allottee shall be responsible for
16 ensuring that these funds, or so much thereof as may be
17 necessary, are used solely for the purpose specified in this
18 act, and that no obligations are incurred in excess of the sum
19 appropriated. The allottee of the funds appropriated under
20 section 1 of this act shall be the President of the Federated
21 States of Micronesia or his designee; PROVIDED THAT, the funds
22 appropriated under subsections 1(d) shall be the Mayor of Lelu
23 Town Government or his designee; the allottee of funds
24 appropriated under subsections 1(2)(1)(a)-(o), 1(2)(2)(a),
25 1(2)(2)(c), 1(2)(3)(a), 1(2)(3)(b), 1(2)(3)(d), 1(2)(3)(f) –

1 (j), 1(2)(3)(l), 1(2)(3)(n), 1(2)(3)(q), 1(2)(4)(a)-(j) shall
 2 be the Pohnpei Transportation Authority (PTA); the allottee of
 3 funds appropriated under subsections 1(2)(2)(b), 1(2)(2)(d),
 4 1(2)(2)(e) and 1(2)(2)(f) shall be the Secretary of the
 5 Department of Transportation, Communication and Infrastructure
 6 or his designee; the allottee of fund appropriated under
 7 subsections 1(2)(4)(k)-(s) shall be the Governor of the State
 8 of Pohnpei. The authority of the allottee to obligate funds
 9 appropriated by this act shall lapse on September 30, 2017."

10 Section 3. This act shall become law upon approval by the
 11 President of the Federated States of Micronesia or upon its
 12 becoming law without such approval.


