
Dear Speaker Simina:

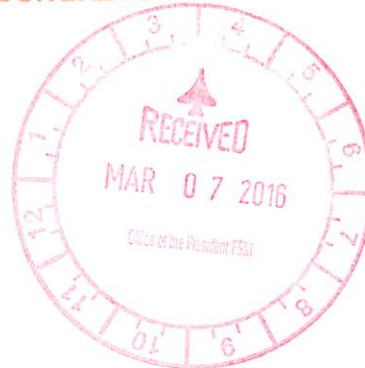

AN ACT

To further amend Public Law No. 19-54, as amended by Public Law No. 19-62, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs in the states of Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 19-54 is hereby

PUBLIC LAW No. 19-75

1 Section 2. Section 6 of Public Law No. 19-54, is hereby
2 amended to read as follows:

3 "Section 6. Allotment and management of funds and
4 lapse date. All funds appropriated by this act shall
5 be allotted, managed, administered and accounted for
6 in accordance with applicable laws, including, but
7 not limited to, the Financial Management Act of 1979.
8 The allottee shall be responsible for ensuring that
9 these funds, or so much thereof as may be necessary,
10 are used solely for the purpose specified in this
11 act, and that no obligations are incurred in excess
12 of the sum appropriated. The allottee of the funds
13 appropriated under section 2 of this act shall be the
14 Governor of Yap State. The allottee of funds
15 appropriated under sections 3 and 4 of this act shall
16 be the President of the Federated States of
17 Micronesia or his designee; PROVIDED THAT, the
18 allottee of funds appropriated under subsections
19 3(a), (b), (c), (d), (e), (f), (g), (h), (i), (j),
20 (k), (l), (m), (n), (o), (p), (q), (r), (s), (t),
21 (u), (v), (ag), (ar) and (as) of this act shall be
22 the Mayor of Lelu Town Government or his designee;
23 the allottee of funds appropriated under subsections
24 3(w), (x), (y), (z), (aa), (ab), (ac), (ad), (ae),
25 (af), (ah), (ai), (aj), (ak), (al), (am), (an), (ao),

1 (ap) and (aq) of this act shall be the Mayor of
2 Tafunsak Municipal Government or his designee; the
3 allottee of funds appropriated under subsections
4 4(1)(a), (b), (c), (e), (f), and 4(2) shall be the
5 Secretary of the Department of Transportation,
6 Communications and Infrastructure or his designee;
7 the allottee of funds appropriated under subsections
8 4(1)(d), 4(3) (b) and (d) shall be the Pohnpei
9 Transportation Authority (PTA). The allottee of
10 funds appropriated under subsections 4(4)(k) and
11 4(4)(j) shall be Pohnpei PUC. The allottee of funds
12 appropriated under subsections 5(1), 5(3) and 5(6) of
13 this act shall be the Governor of Chuuk State or his
14 designee. The allottee of funds appropriated under
15 subsection 5(2) of this act shall be the Mortlock
16 Islands Development Authority. The allottee of funds
17 appropriated under subsection 5(4) of this act shall
18 be the Southern Namoneas Development Authority except
19 for subsection 5(4)(e) for which the allottee shall
20 be the Governor of Chuuk. The allottee of funds
21 appropriated under subsection 5(5) of this act shall
22 be the Faichuk Development Authority. The authority
23 of the allottee to obligate funds appropriated by
24 this act shall lapse on September 30, 2017."

PUBLIC LAW No. 19-75

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.


