



PUBLIC LAW No. 19-03

AN ACT

To further amend Public Law No. 18-05, as amended by Public Laws Nos. 18-07, 18-14, 18-31, 18-38, 18-72, 18-82, 18-93 and 18-105, by amending sections 5 and 6 thereof, for the purpose of changing the use, allottee and lapse date of funds previously appropriated, to fund public projects and social programs in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 18-05, as amended
2 by Public Laws Nos. 18-07, 18-14 and 18-93, is hereby further
3 amended to read as follows:

4 "Section 5. Of the sum of \$2,500,000 appropriated by
5 this act, \$1,000,000, is apportioned for Chuuk State
6 for public projects and social programs.

PUBLIC LAW No. 19-03

1 Section 2. Section 6 of Public Law No. 18-05, as amended
2 by Public Laws Nos. 18-07, 18-38 and 18-82, is hereby further
3 amended to read as follows:


4 "Section 6. Allotment and management of funds and
5 lapse date. All funds appropriated by this act shall
6 be allotted, managed, administered and accounted for
7 in accordance with applicable laws, including, but
8 not limited to, the Financial Management Act of 1979.
9 The allottee shall be responsible for ensuring that
10 these funds, or so much thereof as may be necessary,
11 are used solely for the purpose specified in this
12 act, and that no obligations are incurred in excess
13 of the sum appropriated. The allottee of the funds
14 appropriated under section 3 of this act shall be the
15 Governor of Yap State. The allottee of funds
16 appropriated under sections 2 and 4 of this act shall
17 be the President of the Federated States of
18 Micronesia or his designee, EXCEPT THAT the allottee
19 of funds appropriated under subsection 4(3)(a) of
20 this act shall be the Pohnpei Transportation
21 Authority. The allottee of funds appropriated under
22 subsections 5(1), 5(3) and 5(6) of this act shall be
23 the Governor of Chuuk State or his designee. The
24 allottee of funds appropriated under subsection 5(2)
25 of section 5 of this act shall be the Mortlock

1 Islands Development Authority. The allottee of funds
2 appropriated under subsection 5(4) of section 5 of
3 this act shall be the Southern Namoneas Development
4 Authority. The allottee of funds appropriated under
5 subsection 5(5) of section 5 of this act shall be the
6 Faichuk Development Authority. The authority of the
7 allottee to obligate funds appropriated by this act
8 shall lapse on September 30, 2016."

9 Section 3. This act shall become law upon approval by the
10 President of the Federated States of Micronesia or upon its
11 becoming law without such approval.
