

AN ACT

To further amend Public Law No. 18-11, as amended by Public Laws Nos. 18-44, 18-81, 19-33, 19-106 and 19-128, by amending section 1 thereof, to correct a technical error, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 1 of Public Law No. 18-11, as amended  
2 by Public Laws Nos. 18-44 and 19-128, is hereby further amended  
3 to read as follows:

4               "Section 1. The sum of \$1,680,000, or so much thereof  
5 as may be necessary, is hereby appropriated from the  
6 General Fund of the Federated States of Micronesia for  
7 the fiscal year ending September 30, 2013, for the  
8 purpose of funding public projects and social programs  
9 in the states of Pohnpei and Yap. The funds shall be  
10 apportioned as follows:

11               (1) Pohnpei State ..... \$    1,130,000

12       PROVIDED, HOWEVER, that the funds appropriated in  
13 subsections (b)(c)(d) and (e) of this section shall  
14 not be allotted until Congress is officially advised  
15 that funds improperly disbursed as a result of the  
16 line item veto which was reflected in Public Law No.  
17 18-11 are collected.


