AN ACT

To further amend Public Law No. 19-124, as amended by Public Laws Nos. 19-133 and 19-140, by amending section 5 thereof, to change the use of funds previously appropriated therein to fund priority infrastructure projects and other programs in the state of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
