AN ACT

To appropriate the sum of \$273,042 from the General Fund of the Federated States of Micronesia for the purpose of defraying the operating and contingent expenses of the Congress of the Federated States of Micronesia for the first quarter of Fiscal Year 1981, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Operating expenses of the Office of the Speaker and
2	Members. The sum of \$113,590, or so much thereof as may be necessary,
3	is hereby appropriated from the General Fund of the Federated States of
4	Micronesia for the Fiscal Year ending September 30, 1981, for the purpose
5	of defraying the operating and contingent expenses of the Office of the
6	Speaker and other Members of the Congress of the Federated States of
7	Micronesia. The sum appropriated by this section shall be apportioned
8	as follows:
9	(1) Members' salaries
10	(2) Members' personnel and health benefits 2,250
11	(3) Representation allowance
12	(4) Members' office rental 3,500
13	(5) Members' travel
14	(6) Standing committees
15	Section 2. Operating expenses of staff offices of the Congress.
16	The sum of \$129,302, or so much thereof as may be necessary, is hereby
17	appropriated from the General Fund of the Federated States of Micro-
18	nesia for the Fiscal Year ending September 30, 1981, for the purpose of
19	defraying the operating and contingent expenses of staff offices of the
20	Congress and shall be apportioned as follows:
21	(1) Staff salaries
22	(2) Staff personnel and health benefits 5,445

1	(3) Staff housing allowance
2	(4) Staff travel 8,000
3	(5) Recruitment, home leave and repatriation 5,000

5	Section 3. Miscellaneous expenses of the Congress. The sum of
6	\$30,150, or so much thereof as may be necessary, is hereby appropriated
7	from the General Fund of the Federated States of Micronesia for the
8	Fiscal Year ending September 30, 1981 for the purpose of defraying miscel-
9	laneous expenses of the Congress of the Federated States of Micronesia and
10	shall be apportioned as follows:
11	(1) Equipment, furniture and books \$ 8,250
12	(2) Rent and Communications
13	(3) Other services
14	(4) Printing and reproduction 2,500
15	(5) Materials and supplies 4,900
16	(6) Freight
17	(7) Repairs and maintenance 2,250
18	Section 4. Allotment and responsibility of funds appropriated. The
19	funds appropriated by this act shall be allotted to the Speaker of the
20	Congress of the Federated States of Micronesia or his designees, and those
21	those funds shall be administered and managed in accordance with appli-
22	cable law, including the Financial Management Act of 1979. The Speaker
23	of the Congress of the Federated States of Micronesia shall have the
24	authority to reallot funds appropriated by one subsection within a
25	section to another subsection within the same section; PROVIDED, HOWEVER,

1	that not more than ten percent of the funds appropriated by a section of
2	this act shall be reallotted to another section of this act; PROVIDED
3	FURTHER, HOWEVER, that no funds shall be reallotted to recruit
4	unbudgeted personnel. The authority to obligate funds appropriated by
5	this act shall lapse as of September 30, 1981.
6	Section 5. Effective Date. This act shall become law upon the
7	approval by the President of the Federated States of Micronesia, or upon
8	its becoming law without such approval.
