

AN ACT

To amend Public Law No. 1-116 to provide full-year funding for the operations of the Congress of the Federated States of Micronesia during Fiscal Year 1981 by increasing the amount previously appropriated to \$1,230,000, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 1-116 is hereby amended to
2 read as follows:

3 "Section 1. Operating expenses of the Office of the Speaker
4 and Members. The sum of \$535,000, or so much thereof as may be
5 necessary, is hereby appropriated from the General Fund of the
6 Federated States of Micronesia for the Fiscal Year ending
7 September 30, 1981, for the purpose of defraying the operating
8 and contingent expenses of the Office of the Speaker and other
9 Members of the Congress of the Federated States of Micronesia.
10 The sum appropriated by this section shall be apportioned as
11 follows:

12	(1) Members' salaries	\$213,000
13	(2) Members' personnel and health benefits . . .	11,000
14	(3) Representation allowance.	5,000
15	(4) Office rental allowance of \$2,400 per member.	22,000
16	(5) Members' travel	109,000
17	(6) Standing committees	105,000
18	(7) Official expense allowance of \$5,000 per	
19	member.	70,000"

20 Section 2. Section 2 of Public Law No. 1-116 is hereby amended to
21 read as follows:

22 "Section 2. Operating expenses of staff offices of the Congress.

1 The sum of \$555,000, or so much thereof as may be necessary, is
2 hereby appropriated from the General Fund of the Federated
3 States of Micronesia for the Fiscal Year ending September 30,
4 1981, for the purpose of defraying the operating and contingent
5 expenses of staff offices of the Congress and shall be
6 apportioned as follows:

7	(1) Staff salaries	\$412,000
8	(2) Staff personnel and health benefits.	26,000
9	(3) Staff housing allowance.	43,000
10	(4) Staff travel	20,000
11	(5) Recruitment, home leave and repatriation . .	26,000
12	(6) Contractual services	10,000
13	(7) Staff training	18,000"

14 Section 3. Section 3 of Public Law No. 1-116 is hereby amended to
15 read as follows:

16 "Section 3. Miscellaneous expenses of the Congress. The sum of
17 \$140,000, or so much thereof as may be necessary, is hereby
18 appropriated from the General Fund of the Federated States of
19 Micronesia for the Fiscal Year ending September 30, 1981 for the
20 purpose of defraying miscellaneous expenses of the Congress of
21 the Federated States of Micronesia and shall be apportioned as
22 follows:

23	(1) Equipment, furniture and books	\$ 35,000
24	(2) Rent and Communications.	18,000
25	(3) Health insurance	7,500

1	(4) Printing and reproduction	\$ 18,000
2	(5) Materials and supplies.	22,000
3	(6) Freight	3,000
4	(7) Repairs and maintenance	2,500

7	(10) Utilities	6,000"

8 Section 4. Section 4 of Public Law No. 1-116 is hereby amended to
9 read as follows:

10 "Section 4. Allotment and responsibility of funds appropriated.
11 All funds appropriated by this act shall be allotted, managed,
12 administered and accounted for in accordance with applicable
13 law, including, but not limited to, the Financial Management Act
14 of 1979. The allottee shall be responsible for ensuring that
15 these funds, or so much thereof as may be necessary, are used
16 solely for the purposes specified in this act, and that no
17 obligations are incurred in excess of the sum appropriated. The
18 Speaker of the Congress of the Federated States of Micronesia
19 shall have the authority to reallot funds appropriated by one
20 subsection within a section to another subsection within the
21 same section; PROVIDED, HOWEVER, that not more than ten percent
22 of the funds appropriated by a section of this act shall be
23 reallotted to another section of this act; PROVIDED FURTHER,
24 HOWEVER, that no funds shall be reallotted to recruit unbudgeted
25 personnel. The authority to obligate funds appropriated by this

1 act shall lapse as of September 30, 1981."

2 Section 5. This act shall become law upon approval by the President
3 of the Federated States of Micronesia, or upon its becoming law without
4 such approval.
