CONGRESSIONAL BILL NO. 1-335, C.D.1

AN ACT

To amend Public Law No. 1-118 to provide full-year funding for the operations of the executive branch, national judiciary, Public Auditor, and other programs of the National Government of the Federated States of Micronesia during Fiscal Year 1981 by increasing the amount previously appropriated to \$2,229,000, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
