	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Operating Expenses of the Office of the Legislative
2	Counsel.
3	(1) The sum of \$16,200, or so much thereof as may be
4	necessary, is hereby appropriated from the General Fund of the
5	Congress of the Federated States of Micronesia as a supplemental
6	appropriation for the operation and contingent expenses of the
7	Office of the Legislative Counsel for a period of six months
8	beginning on April 1 through September 30, 1979. The sum
9	appropriated shall be apportioned as follows:
10	(a) Travel
11	(b) Repatriation and home leave 13,200
12	(2) The sum appropriated by this Section shall be
13	allotted to the Legislative Counsel who shall be responsible to the
14	First Congress of the Federated States of Micronesia for ensuring
15	that these funds are used only for the purposes herein specified and
16	that no obligations are incurred in excess of the sum appropriated.
17	Section 2. Miscellaneous Expenses.
18	(1) The sum of \$25,200, or so much thereof as may be
19	necessary, is hereby appropriated from the General Fund of the
20	Congress of the Federated States of Micronesia as a supplemental
21	appropriation for the miscellaneous expenses of the Interim and the

22 First Congresses of the Federated States of Micronesia. The sum

1	appropriated shall be apportioned as follows:
2	(a) Housing allowance \$ 4,400
3	(b) Inauguration expenses 10,000
4	(c) Office rentals 8,700
5	(d) Interpreter's expenses 900
6	(e) Proofreader and secretarial services 1,200
7	(2) The sum appropriated by this Section shall be allotted
8	to the Clerk of the Congress and the Legislative Counsel who shall be
9	jointly responsible to the First Congress of the Federated States of
10	Micronesia for ensuring that these funds are used only for the
11	purposes specified herein and that no obligations are incurred in
12	excess of the sum appropriated.
13	Section 3. Reversion of Funds. Any part of the funds
14	appropriated by this act not obligated as of September 30, 1979, shall
15	revert to the General Fund of the Congress of the Federated States of
16	Micronesia.
17	Section 4. Reports Required. The allottees responsible for the
18	expenditure of the funds under this act shall submit a report to the
19	Congress of the Federated States of Micronesia before October 15, 1979
20	which shall provide for the full accounting by object class of the
21	obligations incurred against the sum appropriated by this act.

23	Section 5. Administration of Funds. All sums appropriated by
24	this act shall be administered by the Finance Officer of the Congress
25	of the Federated States of Micronesia.
