AN ACT

To amend Public Law No. 1-84, which appropriated funds for certain public projects in the State of Ponape, to permit additional projects to be funded out of the sum appropriated, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 1 of Public Law No. 1-84 is hereby amended to  
2 read as follows:

3       "Section 1. The sum of \$560,000, or so much thereof as may  
4 be necessary, is hereby appropriated from the General Fund of  
5 the Federated States of Micronesia for the fiscal year  
6 ending September 30, 1980, for the purpose of funding public  
7 projects in the State of Ponape. The sum appropriated shall  
8 be apportioned as follows:

9               (1) Construction of Ponape circumferential  
10 road . . . . . \$300,000

11               (2) Construction of airstrips and related  
12 transportation infrastructure for Pingelap,  
13 Mokil and Ngatik . . . . . \$ 80,000

14               (3) Typhoon relief for Kapingamarangi. . . . . \$ 20,000

15               (4) Public projects for Nukuoro. . . . . \$ 20,000

16               (5) Construction of Farm Roads or classrooms:

17                       (a) Madolenihmw . . . . . \$ 16,000

18                       (b) Sokehs. . . . . \$116,000

19                       (c) Kitti . . . . . \$ 16,000

20                       (d) Kolonia . . . . . \$ 20,000

21               (6) Construction of Farm Roads, classrooms

22 or water systems:

1 (a) Uh . . . . . \$ 16,000  
2 (b) Nett . . . . . \$ 16,000  
3 (7) Construction of roads around Sokehs and  
4 Temwen Islands. . . . . \$ 40,000"

5 Section 2. Section 2 of Public Law No. 1-84 is hereby amended to  
6 read as follows:

7 "Section 2. The funds herein appropriated shall be  
8 administered and managed in accordance with the provisions of  
9 the Financial Management Act of 1979, provided that line items  
10 (4), (5), (6) and (7) shall not be obligated prior to  
11 August 1, 1980; provided further, however, that no more than  
12 25% of the funds apportioned by paragraphs (c) and (d) of  
13 line item (5) may be obligated immediately upon the effective  
14 date of this act. Any part of this appropriation not  
15 obligated as of September 30, 1981, shall revert to the  
16 General Fund of the Federated States of Micronesia."

17 Section 3. This act shall become law upon approval by the  
18 President of the Federated States of Micronesia, or upon its becoming  
19 law without such approval.
