

AN ACT

To appropriate the sum of \$227,600 from the General Fund of the Federated States of Micronesia for the Fiscal Year ending September 30, 1981, for the purpose of funding public projects within the State of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$227,600, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Federated
3 States of Micronesia for the Fiscal Year ending September 30, 1981, for
4 the purpose of funding public projects within the State of Yap. The sum
5 appropriated shall be apportioned in accordance with the following
6 schedule:

- 7 (1) Outer Islands:
- 8 (a) Renovation and repair of the Outer Islands High
9 School cafeteria \$50,000
 - 10 (b) Radio beacon for Woleai Airport. 15,000
 - 11 (c) Construction of Satawal water catchment. 6,000
 - 12 (d) Construction of Ifaluk water catchment 7,000
 - 13 (e) Construction of Falalis water catchment. 7,000
 - 14 (f) Community projects for Fassarai, Asor and
15 Mogmog 30,000
- 16 (2) Yap Islands proper:
- 17 (a) Extension of North Fanif road. 15,000
 - 18 (b) Purchase of a wheel loader for Yap
19 Transportation and Construction Authority or its successor 29,000
 - 20 (c) Purchase of a dump truck for Yap
21 Transportation and Construction Authority or its successor 30,000
 - 22 (d) Phase I construction of Tomil road 25,000

5 Section 2. The funds apportioned by Subsection (1) of Section 1
6 and Paragraphs (a) through (d) of Subsection (2) of Section 1 shall be
7 allotted to the Governor of the State of Yap, who is authorized to
8 reallocate such funds from one paragraph of a subsection to another
9 paragraph of a subsection; PROVIDED, HOWEVER, that not more than fifteen
10 (15) percent of the funds allotted to one paragraph may be reallocated
11 to another paragraph. The funds apportioned by Paragraphs (e) and (f)
12 of Subsection (2) of Section 1 are allotted to the Speaker of the
13 Congress. All funds appropriated and apportioned by this act shall be
14 managed, administered and accounted for in accordance with applicable
15 law, including, but not limited to, the Financial Management Act of
16 1979. The allottee shall be responsible for ensuring that these funds,
17 or so much thereof as may be necessary, are used solely for the purposes
18 specified in this act, and that no obligations are incurred in excess of
19 the sum appropriated. The authority of the allottee to obligate funds
20 appropriated by this act shall lapse as of September 30, 1982.
