
Dear Speaker Simina:

CONGRESSIONAL BILL NO. 20-309

AN ACT

To amend section 209 of title 2 of the Code of the Federated States of Micronesia (Annotated), to increase the salaries of the President and Vice President of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 209 of title 2 of the Code of the
2 Federated States of Micronesia (Annotated), is hereby amended
3 to read as follows:

4 "Section 209. Salaries for President and Vice
5 President.

6 As of the date of the commencement of their terms of
7 office, the President of the Federated States of
8 Micronesia shall receive a salary of \$80,000 per
9 annum, and the Vice President shall receive a salary
10 of \$70,000 per annum. The President or Vice
11 President shall continue to receive the salary set
12 hereby until their successors take office. Should a
13 vacancy in either office occur, the successor shall
14 be entitled to the salary attendant to the office
15 assumed as of the date of succession."

PUBLIC LAW No. 20-183

1 Section 2. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.


