
Dear Speaker Simina:

CONGRESSIONAL BILL NO. 20-287

AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia (Annotated), as amended, by renumbering the chapter and sections created by Public Law No. 18-100, to correct a technical error, to reserve chapter 16, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The purpose of this Act is to renumber the
2 chapter and sections of title 55 of the Code of the Federated
3 States of Micronesia (Annotated) enacted by Public Law No.
4 18-100. Public Law No. 18-100 enacted chapter 16 and
5 sections 1601-1603 of title 55; however, those section
6 numbers were already in use under chapter 6 of title 55.
7 This act renumbers chapter 16 of title 55 as chapter 17,
8 renumbers sections 1601-1603 of title 55 enacted under Public
9 Law No. 18-100 as sections 1701-1703, and reserves chapter 16
10 of title 55 to prevent similar technical errors.

11 Section 2. Chapter 16 of title 55 of the Code of the
12 Federated States of Micronesia (Annotated), as enacted by
13 Public Law No. 18-100, is hereby renumbered as chapter 17.

14 Section 3. Sections 1601-1603 of title 55 of the Code
15 of the Federated States of Micronesia (Annotated), as enacted
16 by Public Law No. 18-100, are hereby renumbered as sections
17 1701-1703.

18 Section 4. Chapter 16 of title 55 of the Code of the

1 Federated States of Micronesia (Annotated) is hereby titled

2 "Reserved".

3 Section 5. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its
5 becoming law without such approval.


