- 1 WHEREAS, section 104 of title 55 of the Code of the
- 2 Federated States of Micronesia (Annotated), as amended,
- 3 requires that Congress adopt a resolution setting forth the
- 4 total funds estimated to be available from the General Fund and
- 5 any special funds of the Treasury of the Federated States of
- 6 Micronesia for each fiscal year; now, therefore,
- 7 BE IT RESOLVED by the Twentieth Congress of the Federated
- 8 States of Micronesia, Third Regular Session, 2018, that the
- 9 amount estimated to be available for the fiscal year ending
- 10 September 30, 2018, is set at \$97,343,979 of which \$90,479,109
- 11 is from domestic revenues, and \$5,252,250 will be available
- 12 from amended Compact Sector for COM-FSM and \$1,612,620 will be
- 13 available from the Supplemental Education Grant; and
