CONGRESSIONAL RESOLUTION NO. 20-187

A RESOLUTION

Approving and accepting a grant in the amount of \$500,000 from the World Health Organization (the "WHO"), to support identified priority areas agreed to by the FSM Department of Health and Social Affairs and the WHO in the Country Cooperation Strategy (CCS) 2018-2020, including all the terms and conditions of the assistance.

1 WHEREAS, on February 27, 2019, the WHO Country Liaison
2 Officer confirmed in writing to the FSM Secretary of Health and
3 Social Affairs that the WHO is providing funding in the amount of
4 \$500,000, to support the FSM National Health Priority general
5 areas, among them: universal health coverage, building
6 international health regulation, capacity building for non-
7 communicable disease prevention and control, and social
8 development; and

9 WHEREAS, section 210(2) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended, provides
11 that for foreign financial assistance to be valid it must be
12 approved by Congress by resolution; now, therefore,


13 BE IT RESOLVED by the Twentieth Congress of the Federated
14 States of Micronesia, Seventh Special Session, 2019, that Congress
15 hereby approves and accepts the \$500,000 grant from the WHO,


