CONGRESSIONAL RESOLUTION NO. 20-191

A RESOLUTION

Approving and accepting a grant in the amount of \$250,000 from the U.S. Department of Health and Human Services, Administration on Children, Youth and Families, to fund and support the Personal Responsibility Education Program in the FSM for the fiscal year 2019, including all the terms and conditions of the assistance.

1 WHEREAS, on January 09, 2019, the U.S. Department of Health
2 and Human Services, Administration on Children, Youth and
3 Families, issued a Notice of Award of financial assistance in the
4 amount of \$250,000, to fund the Personal Responsibility Education
5 Program in the FSM; and

6 WHEREAS, the purpose of this grant is to fund the
7 implementation of the Personal Responsibility Education Program
8 (PREP) for the early intervention for teens ages 15-19, to address
9 unhealthy, risky behaviors such as early pregnancy, incomplete
10 educational goals and negative peer pressure under the Personal
11 Responsibility Education Program; and

12 WHEREAS, section 210 (2) of title 55 of the Code of the
13 Federated States of Micronesia (Annotated), as amended, requires
14 that for foreign financial assistance to be valid it must be
15 approved by Congress by resolution; now, therefore,

16 BE IT RESOLVED by the Twentieth Congress of the Federated
17 States of Micronesia, Seventh Special Session, 2019, that Congress
18 hereby approves and accepts the \$250,000 grant from the U.S.
19 Department of Health and Human Services, Administration for

1 Children, Youth and Families, to fund the Personal Responsibility
2 Education Program in the FSM for the fiscal year 2019, including
3 all terms and conditions therefore; and

4 BE IT FURTHER RESOLVED that certified copies of this
5 resolution be transmitted to the President of the Federated States
6 of Micronesia and the Secretary of the Department of Health and
7 Social Affairs.


