AN ACT

To further amend Public Law No. 19-89, as amended by Public Laws Nos. 19-94, 19-127, 19-151, 19-159, 20-06, 20-32, 20-136 and 21-13, by amending section 5 thereof, to change the use of funds previously appropriated therein, for the purpose of funding public projects and social programs in the state of Chuuk, and for other purposes.
