AN ACT

To further amend Public Law No. 20-178, as amended by Public Laws Nos. 21-01, 21-07, 21-36 and 21-53, by amending sections 3, 4, 5 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

11 Section 5. Section 6 of Public Law No. 20-178, as amended by
12 Public Laws Nos. 21-01 and 21-36 and 21-53, is hereby amended to
13 read as follows:

14 "Section 6. Allotment and management of funds and lapse
15 date. All funds appropriated by this act shall be
16 allotted, managed, administered and accounted for in
17 accordance with applicable laws, including, but not
18 limited to, the Financial Management Act of 1979. The
19 allottee shall be responsible for ensuring that these
20 funds, or so much thereof as may be necessary, are used
21 solely for the purpose specified in this act, and that
22 no obligations are incurred in excess of the sum
23 appropriated. The allottee of the funds appropriated
24 under section 2 of this act shall be the Governor of Yap
25 State or his designee. The allottee of funds

1 appropriated under section 3 of this act shall be the
2 Governor of Kosrae State or his designee; PROVIDED THAT
3 the allottee of funds appropriated under subsections
4 3(ad) of this act and 4(2)(q) shall be the President of
5 COM-FSM or his designee; the allottee of funds
6 appropriated under subsections 3(ae) to 3(ak) of this
7 act shall be the Mayor of Lelu Town Government or his
8 designee. The allottee of funds appropriated under
9 subsection 3(al) of this act shall be the Secretary of
10 the FSM Department of Education or his designee. The
11 allottee of funds appropriated under section 4 of this
12 act shall be the President of the Federated States of
13 Micronesia or his designee; PROVIDED THAT the allottee
14 of funds appropriated under section 4(1) and subsection
15 4(3)(w) of this act shall be the Vice President of the
16 Federated States of Micronesia or his designee; the
17 allottee of funds appropriated under subsections
18 4(3)(a), 4(3)(b) and 4(3)(c) of this act shall be the
19 Secretary of the Department of Health and Social Affairs
20 or her designee; the allottee of funds appropriated
21 under subsections 4(3)(d), 4(3)(y) and 4(3)(z) of this
22 act shall be the Secretary of the Department of
23 Education or his designee; the allottee of funds
24 appropriated under subsections 4(4)(f) and 4(3)(p) of
25 this act shall be the Pohnpei Transportation Authority,

1 the funds appropriated under subsection 4(3)(g) of this
2 act shall be the President of the Federated States of
3 Micronesia or his designee, the allottee of funds
4 appropriated under subsection 4(3)(x) of this act shall
5 be the Meninkeder Lapalap of Madolenihmw Municipal
6 Government or his designee; the funds appropriated under
7 subsections 4(3)(i) and 4(3)(j) of this act shall be the
8 Secretary of the Department of Transportation,
9 Communications and Infrastructure or his designee; The
10 allottee of the funds appropriated under subsections
11 5(1), 5(3) and 5(6) of this act shall be the Governor of
12 Chuuk State or his designee; the allottee of the funds
13 appropriated under subsection 5(2) of this act shall be
14 the Mortlocks Island Development Authority (MIDA); the
15 allottee of the funds appropriated under subsection 5(4)
16 of this act shall be the Southern Namoneas Development
17 Authority; the allottee of the funds appropriated under
18 subsection 5(5) of this act shall be the Faichuk
19 Development Authority. The authority of the allottee to
20 obligate funds appropriated by this act shall lapse on
21 September 30, 2020."

1 Section 6. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
