AN ACT

To further amend Public Law No. 21-43, as amended by Public Law No. 21-54, by amending section 6 thereof, to change the allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 21-43, as amended by
- 2 Public Law No. 21-54, is hereby further amended to read as
- 3 follows:

4 "Section 6. Allotment and management of funds and lapse date. All funds appropriated by this act shall be 5 6 allotted, managed, administered and accounted for in 7 accordance with applicable laws, including, but not limited to, the Financial Management Act of 1979. 8 allottee shall be responsible for ensuring that these 9 funds, or so much thereof as may be necessary, are used 10 11 solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum 12 The allottee of the funds appropriated 13 under section 2 of this act shall be the Governor of Yap 14 15 State or his designee; PROVIDED THAT, the allottee of funds appropriated under subsection 2(f) of this act shall 16 be the President of the COM-FSM. The allottee of funds 17 appropriated under sections 3 and 4 of this act shall be 18

the President of the Federated States of Micronesia or his
designee; PROVIDED THAT, the allottee of funds
appropriated under subsection 3(1) of this act shall be
the Governor of Kosrae State or his designee; the allottee
of funds appropriated under subsection 3(2) of this act
shall be the Mayor of Lelu Town Government or his
designee. The allottee of funds appropriated under section
4(1) and 4(3)(1) of this act shall be the Vice President;
The allottee of funds appropriated under subsection
4(1)(a) and section 4(2) of this act shall be the
Secretary of the Department of Transportation,
Communications and Infrastructure or his designee, except
that the allottee of funds appropriated under subsections
4(2)(e), $4(4)(j)$, $4(4)(k)$, $4(4)(1)$ and $4(4)(m)$ of this act
shall be the Pohnpei Transportation Authority (PTA); the
allottee of funds appropriated under subsections 4(2)(1),
4(3)(d) and 4(3)(f) of this act shall be the Secretary of
the Department of Education or his designee; the allottee
of funds appropriated under subsection 4(2)(h) of this act
shall be the President of COM-FSM; the allottee of funds
appropriated under subsections 4(3)(a), 4(3)(b), 4(3)(e),
4(3)(h), $4(3)(i)$ and $4(3)(k)$ of this act shall be the
Meninkeder of Madolenihmw; the allottee of funds
appropriated under subsection 4(3)(c) of this act shall be
the Chief Justice of Madolenihmw Municipal Government; the

1	allottee of funds appropriated under subsection 4(3)(g) of
2	this act shall be the Luhkenmoanlap of Kitti; the allotted
3	of funds appropriated under subsection 4(3)(j) of this ac-
4	shall be the Speaker of Isokonedi of Kitti; the allottee
5	of funds appropriated under subsection 4(3)(m) of this ac
6	shall be the Director of Pohnpei Public Safety. The
7	allottee of the funds appropriated under sections 5(1),
8	5(3) and 5(6) of this act shall be the Governor of Chuuk
9	State or his designee; the allottee of the funds
10	appropriated under subsection 5(2) of this act shall be
11	the Mortlocks Island Development Authority (MIDA); the
12	allottee of the funds appropriated under subsection 5(4)
13	of this act shall be the Southern Namoneas Development
14	Authority; the allottee of the funds appropriated under
15	subsection 5(5) of this act shall be the Faichuk
16	Development Authority. The authority of the allottee to
17	obligate funds appropriated by this act shall lapse on
18	September 30, 2022."
