
I am pleased to transmit the following Act, which I have signed into Public Law No. 21-72 with item veto:

CONGRESSIONAL BILL NO. 21-112

AN ACT

To further amend Public Law No. 20-151, as amended by Public Law No. 20-165, by amending section 1 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs in the state of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 20-151, as amended by
2 Public Law No. 20-165, is hereby further amended to read as
3 follows:

4 "Section 1. The sum of \$600,000, or so much thereof as may
5 be necessary, is hereby appropriated from the General
6 Fund of the Federated States of Micronesia for the fiscal
7 year ending September 30, 2019, for the purpose of
8 funding public projects and social programs in the state
9 of Chuuk. The funds appropriated under this section shall
10 be apportioned as follows:
