### AN ACT

To further amend Public Law No. 19-89, as amended by Public Laws Nos. 19-94, 19-127, 19-151, 19-159, 20-06, 20-32, 20-136, 21-13 and 21-87, by amending section 6 thereof, to change the allottee and lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1	. Section	6	of	Public	T.aw	No	19_29	26

- 2 amended by Public Laws Nos. 19-94, 19-127, 20-06, 20-136 and
- 3 21-13, is hereby further amended to read as follows:

4	"Section 6. Allotment and management of funds and
5	lapse date. All funds appropriated by this act shall
6	be allotted, managed, administered and accounted for
7	in accordance with applicable laws, including, but not
8	limited to, the Financial Management Act of 1979. The
9	allottee shall be responsible for ensuring that these
10	funds, or so much thereof as may be necessary, are
11	used solely for the purpose specified in this act, and
12	that no obligations are incurred in excess of the sum
13	appropriated. The allottee of the funds appropriated
14	under section 2 of this act shall be the Governor of
15	Yap State; PROVIDED THAT, the allottee of funds
16	appropriated under subsection 2(b) of this act shall
17	be the President of the COM-FSM. The allottee of

funds appropriated under sections 3 and 4 of this act
shall be the President of the Federated States of
Micronesia or his designee; PROVIDED THAT, the
allottee of funds appropriated under subsections 3(a),
3(b), 3(c), 3(d), 3(e) 3(f), 3(g), 3(h), 3(1) and 3(m)
shall be the Mayor of Utwe Municipal Government or his
designee; the allottee of funds appropriated under
subsections $3(i)$ , $3(j)$ , $3(k)$ , $3(p)$ and $3(q)$ shall be
the Mayor of Tafunsak Municipal Government; the
allottee of funds appropriated under subsection
4(2)(c) shall be the Secretary of the FSM Department
of Education or her designee; the allottee of funds
appropriated under subsections 4(2)(a), 4(2)(b),
4(2)(d), 4(2)(e), 4(2)(f), 4(4)(a), 4(4)(b), 4(4)(c),
4(4)(d) and 4(4)(e) shall be the Secretary of the
Department of Transportation, Communications and
Infrastructure or his designee; the allottee of funds
appropriated under subsections 4(3)(a) and 4(3)(b)
shall be the Pohnpei Transportation Authority; the
allottee of funds appropriated under subsection
4(4)(f) shall be the Pohnpei Utility Corporation. The
allottee of funds appropriated under subsections 5(1),
5(4)(e) and 5(6) of this act shall be the Governor of
Chuuk State or his designee. The allottee of funds
appropriated under subsection 5(2) of this act shall

1	be the Mortlock Islands Development Authority. The
2	allottee of funds appropriated under section 5(3) of
3	this act shall be the Mayor of Weno Municipal
4	Government or his designee. The allottee of funds
5	appropriated under subsection 5(4) of this act shall
6	be the Southern Namoneas Development Authority. The
7	allottee of funds appropriated under subsection 5(5)
8	of this act shall be the Faichuk Development
9	Authority. The authority of the allottee to obligate
10	funds appropriated by this act shall lapse on
11	September 30, 2022."
12	Section 2. This act shall become law upon approval by the
13	President of the Federated States of Micronesia or upon its
14	becoming law without such approval.
