CONGRESSIONAL BILL NO. 21-242

AN ACT

To further amend Public Law No. 20-155, as amended by Public Laws Nos. 20-177, 20-188, 21-61, 21-88 and 21-119, by amending sections 4 and 6 thereof, for the purpose of changing the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2. Section 4 of Public Law No. 20-155,
2 as amended by Public Laws Nos. 20-177 and 20-188, is hereby
3 further amended to read as follows:

4 "Section 4. Of the \$1,400,000 appropriated under
5 this act, \$400,000 shall be apportioned for public
6 projects and social programs for the people of Pohnpei
7 State.

11 Section 2. Section 6 of Public Law No. 20-155, as amended by
 12 Public Laws Nos. 20-177, 20-188 and 21-119, is hereby further
 13 amended to read as follows:

14 "Section 6. Allotment and management of funds and lapse
 15 date. All funds appropriated by this act shall be
 16 allotted, managed, administered and accounted for in
 17 accordance with applicable laws, including, but not
 18 limited to, the Financial Management Act of 1979. The
 19 allottee shall be responsible for ensuring that these
 20 funds, or so much thereof as may be necessary, are used
 21 solely for the purpose specified in this act, and that
 22 no obligations are incurred in excess of the sum
 23 appropriated. The allottee of the funds appropriated
 24 under section 2 of this act shall be the Governor of Yap
 25 State or his designee; PROVIDED THAT the allottee of

1 funds appropriated under subsection 2(c) of this act
2 shall be the Speaker of the Congress of the Federated
3 States of Micronesia or his designee. The allottee of
4 funds appropriated under section 3 of this act shall be
5 the Governor of Kosrae State or his designee. The
6 allottee of funds appropriated under section 4 of this
7 act shall be the President of the Federated States of
8 Micronesia or his designee; PROVIDED THAT the allottee
9 of funds appropriated under subsections 4(1)(c) of this
10 act shall be the Governor of Pohnpei State or his
11 designee; the allottee of funds appropriated under
12 subsections 4(2)(a) and 4(2)(b) of this act shall be the
13 Pohnpei Transportation Authority; the allottee of funds
14 appropriated under subsections 4(2)(c), 4(2)(d), 4(2)(e)
15 and 4(2)(g) of this act shall be the Secretary of the
16 Department of Transportation, Communications and
17 Infrastructure or his designee; the allottee of funds
18 appropriated under subsections 4(3)(a), 4(3)(e) and
19 4(3)(f) of this act shall be the Luhken Moanlap of
20 Kitti; the allottee of funds appropriated under
21 subsection 4(3)(g) of this act shall be the Secretary of
22 the Department of Education or his designee. The
23 allottee of funds appropriated under subsection 4(3)(d)
24 of this act shall be the Secretary of the Department of
25 Resources and Development or his designee. The allottee

1 of the funds appropriated under subsections 5(1) and
2 5(6) of this act shall be the Governor of Chuuk State or
3 his designee; the allottee of the funds appropriated
4 under subsection 5(2) of this act shall be the Mortlocks
5 Island Development Authority (MIDA); the allottee of
6 funds appropriated under subsection 5(3) of this act
7 shall be the Mayor of Weno Municipal Government or his
8 designee; the allottee of the funds appropriated under
9 subsection 5(4) of this act shall be the Southern
10 Namoneas Development Authority; the allottee of the
11 funds appropriated under subsection 5(5) of this act
12 shall be the Faichuk Development Authority. The
13 authority of the allottee to obligate funds appropriated
14 by this act shall lapse on September 30, 2021."

15 Section 3. This act shall become law upon approval by the
16 President of the Federated States of Micronesia or upon its
17 becoming law without such approval.
