CONGRESSIONAL BILL NO. 21-318

AN ACT

To further amend Public Law No. 20-93, as amended by Public Laws Nos. 20-98 20-120, 20-133, 21-98 and 21-162, by amending sections 1 and 2 thereof, to change the use and allottee of funds previously appropriated therein, to fund priority infrastructure projects and other public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 1 of Public Law No. 20-93, as
2	amended by Public Laws Nos. 20-98, 20-120, 20-133, 21-98 and
3	21-162, is hereby further amended to read as follows:
4	"Section 1. The sum of \$800,000, or so much thereof
5	as may be necessary, is hereby appropriated from
6	the General Fund of the Federated States of
7	Micronesia for the fiscal year ending September 30,
8	2018, previously appropriated to fund priority
9	infrastructure projects for the state of Kosrae, to
10	fund public projects and social programs in the
11	state of Kosrae. The funds appropriated under this
12	section shall be apportioned as follows:

23	Section 2. Section 2 of Public Law No. 20-93, as amer	nded
24 b	y Public Laws Nos. 20-120 and 21-162, is hereby further an	
	o read as follows:	

1	"Section 2. Allotment and management of funds and laps
2	date. All funds appropriated by this act shall be
3	allotted, managed, administered and accounted for in
4	accordance with applicable laws, including, but not
5	limited to, the Financial Management Act of 1979. The
6	allottee shall be responsible for ensuring that these
7	funds, or so much thereof as may be necessary, are used
8	solely for the purpose specified in this act, and that
9	no obligations are incurred in excess of the sum
10	appropriated. The allottee of the funds appropriated
11	under subsections 1(a) to 1(p) of this act shall be the
12	Governor of Kosrae State or his designee. The allottee
13	of the funds appropriated under subsections 1(p) to
14	1(ag) of this act shall be the Mayor of Lelu Town
15	Government or his designee. The authority of the
16	allottee to obligate funds appropriated by this act
17	shall lapse on September 30, 2022."
