CONGRESSIONAL BILL NO. 21-144

AN ACT

To further amend section 2 of Public Law No. 17-59, as amended by Public Laws Nos. 17-66, 17-70, 17-77, 17-86, 18-21, 18-29, 18-64, 18-83, 19-18, 19-113, 20-126, 21-25, to change the use of certain funds previously appropriated therein, to fund public projects and social programs in the state of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 17-59, as amended
2 by Public Laws Nos. 17-66, 17-70 and 17-77, is hereby further
3 amended to read as follows:

4 "Section 2. Of the sum of \$1,260,000 appropriated by
5 this act, \$180,000 is apportioned for Yap State for
6 public projects and social programs.

7 State of Yap \$ 180,000

8 (a) POL purchase - reimbursement
9 and provisioning 20,000

10 (b) Okau road repair supplemental .. 25,000

11 (c) Yapese COM-FSM fourth year students
12 financial assistance - partial payment
13 for outstanding balances of COM-FSM

14 Yapese students at the National campus 36,500

15 (d) Ngulog village road improvement
16 and men's house repair 35,000

17 (e) Financial assistance for Yapese
18 medical student(s) intern in Fiji 5,000

(f) Yap medical referral supplemental fund for
insured patients that exceeded the \$50,000 threshold
amount from MiCare program \$ 50,000

(g) Waa'gey supplemental funding
provided that written approval by traditional
leaders of the program is provided 8,500"

Section 2. This act shall become law upon approval by the
President of the Federated States of Micronesia or upon its
becoming law without such approval.
