CONGRESSIONAL BILL NO. 21-149

AN ACT

To amend Public Law No. 20-155, as amended by Public Laws Nos. 20-177, 20-188 and 21-61, by amending section 3 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs for the people of Kosrae state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 3 of Public Law No. 20-155 is hereby  
2 amended to read as follows:

3       "Section 3. Of the \$1,400,000 appropriated under this  
4 act, \$200,000 shall be apportioned for public projects and  
5 social programs for the people of Kosrae State.

7       (a) Salary for Chief of Staff—

8       Kosrae State ..... 30,000

9       (b) Kosrae State Government subsidy 100,000

10       (c) Contribution to Kosraean Women

11       Association — Kolonia ..... 10,000

12       (d) Contribution to community

13       events, activities, programs ..... 15,000

14       (e) Gateway meeting house renovation 10,000

15       (f) Contribution to SDA students- Kosrae 15,000

16       (g) Contribution to Bully

17       Hayes softball team ..... 20,000"

1       Section 2. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its  
3 becoming law without such approval.
