## A RESOLUTION

Authorizing the President of the Federated States of Micronesia to access the Disaster Assistance Emergency Fund ("DAEF") for expenditures related to the Coronavirus public health emergency.

- WHEREAS, the President of the FSM has declared a public 1
- 2 health emergency on January 30, 2020; and
- WHEREAS, said declaration included an authorization to 3
- utilize funds in the Disaster Assistance Emergency Fund ("DAEF")
- under the Compact of Free Association; and 5
- WHEREAS, on February 12, 2020, the Congress by resolution 6
- terminated the President's authority to access the DAEF, and
- authorizing the President instead to access the domestically-
- funded Disaster Relief Fund under title 55 of the Code of the
- 10 Federated States of Micronesia (Annotated); and
- WHEREAS, the coronavirus crisis is continuing and may exceed 11
- 12 the capacity of the Disaster Relief Fund; now, therefore,
- 13 BE IT RESOLVED by the Twenty-First Congress of the Federated
- States of Micronesia, Fourth Special Session, 2020, that the
- President is authorized to access as needed up to \$2,000,000 of 15
- the DAEF for the duration of the public health emergency declared 16
- on January 30, 2020; PROVIDED, HOWEVER that the President must 17
- comply with all conditions appurtenant to the use of the DAEF 18
- under the Compact of Free Association, including but not limited 19
- 20 to the consent as required of the United States Chief of Mission
- 21 in the FSM.
