



CONGRESSIONAL BILL NO. 22-82, C.D.1

---

AN ACT

To appropriate the sum of \$350,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2022, for the purpose of funding vessel purchase for the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. The sum of \$350,000, or so much thereof as may be  
2 necessary, is hereby appropriated from the General Fund of the  
3 Federated States of Micronesia for the fiscal year ending  
4 September 30, 2022, for the purpose of funding vessel purchase for  
5 the state of Pohnpei. The funds appropriated under this section  
6 shall be apportioned as follows:

7	State of Pohnpei.....	\$ 350,000
8	(a) Vessel Purchase.....	350,000

9           Section 6. Allotment and management of funds and lapse date.  
10 All funds appropriated by this act shall be allotted, managed,  
11 administered and accounted for in accordance with applicable laws,  
12 including, but not limited to, the Financial Management Act of  
13 1979. The allottee shall be responsible for ensuring that these  
14 funds, or so much thereof as may be necessary, are used solely for  
15 the purpose specified in this act, and that no obligations are  
16 incurred in excess of the sum appropriated. The allottee of the  
17 funds appropriated under section 2 of this act shall be the  
18 Secretary of the Department of Transportation, Communications and



1 Infrastructure or his designee. The authority of the allottee to  
2 obligate funds appropriated by this act shall lapse on September  
3 30, 2023.

4 Section 3. This act shall become law upon approval by the  
5 President of the Federated States of Micronesia or upon its  
6 becoming law without such approval.
