

AN ACT

To amend Public Law No. 22-48, as amended by Public Law No. 22-52, by amending sections 5 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs in the states of Pohnpei and Chuuk, and for other purposes.

6	Section 2. Section 6 of Public Law No. 22-48, as amended by
7	Public Law No. 22-52, is hereby further amended to read as follow:
8	"Section 6. Allotment and management of funds and lapse
9	date. All funds appropriated by this act shall be
10	allotted, managed, administered and accounted for in
11	accordance with applicable laws, including, but not
12	limited to, the Financial Management Act of 1979. The
13	allottee shall be responsible for ensuring that these
14	funds, or so much thereof as may be necessary, are used
15	solely for the purpose specified in this act, and that no
16	obligations are incurred in excess of the sum
17	appropriated. The allottee of the funds appropriated
18	under section 2 of this act shall be the Governor of Yap
19	State or his designee. The allottee of funds
20	appropriated under section 3(1) of this act shall be the
21	Governor of Kosrae State or his designee. The allotee of
22	funds appropriated under section 3(2) shall be the Mayor
23	Lelu Town Government or his designee. The allottee of
24	funds appropriated under section 4 of this act shall be
25	the President of the Federated States of Micronesia or

1	his designee; EXCEPT THAT, the allottee of funds
2	appropriated under subsection 4(1)(i) of this act shall
3	be the Mayor of Pingelap Municipal Government; the
4	allottee of funds appropriated under subsections 4(1)(c),
5	4(2)(a), 4(2)(b), 4(2)(d), 4(2)(e), 4(2)(i), 4(2)(1),
6	4(3)(b), $4(3)(c)$, $4(3)(e)$, $4(3)(j)$, $4(3)(k)$ $4(4)(a)$,
7	4(4)(b), $4(4)(d)$, $4(4)(e)$ and $4(4)(h)$ of this act shall
8	be the Pohnpei Transportation Authority, (PTA); the
9	allottee of funds appropriated under subsections 4(1)(a),
10	4(1)(b), 4(1)(d), 4(1)(e), 4(1)(f), 4(1)(g), 4(1)(h),
11	4(2)(c), $4(2)(f)$, $4(2)(g)$, $4(2)(j)$, $4(2)(k)$, $4(2)(m)$,
12	4(2)(n), $4(3)(d)$, $4(3)(f)$, $4(3)(g)$, $4(3)(g)$, $4(3)(h)$ and
13	4(3)(i) of this act shall be the Secretary of the
14	Department of Transportation, Communications and
15	Infrastructure or his designee; the allottee of funds
16	appropriated under subsections 4(2)(h) of this act shall
17	be the Mayor of Kolonia Town Government or his designee;
18	the allottee of funds appropriated under subsection
19	4(3)(a) of this act shall be the Luhk en Moanlap of
20	Kitti; the allottee of funds appropriated under
21	subsection 4(4)(i) of this act shall be the Mayor of
22	Mwokilloa Municipal Government or his designee; the
23	allottee of funds appropriated under subsection 4(4)(j)
24	of this act shall be the Mayor of Pingelap Municipal
25	Government or his designee. The allottee of the funds

1	appropriated under sections 5(1) and 5(6) of this act
2	shall be the Governor of Chuuk State or his designee.
3	The allottee of the funds appropriated under section 5(2)
4	of this act shall be the Mortlock Islands Development
5	Authority. The allottee of the funds appropriated under
6	section 5(3) of this act shall be the Mayor of Weno
7	Municipal Government or his designee. The allottee of
8	the funds appropriated under section 5(4) of this act
9	shall be the Southern Namoneas Development Authority.
10	The allottee of the funds appropriated under section 5(5)
11	of this act shall be the Faichuk Development Authority,
12	EXCEPT THAT the allottee of funds appropriated under
13	subsection 5(5)(a) of this act shall be the Chuuk Public
14	Utility Corporation (CPUC). The authority of the
15	allottee to obligate funds appropriated by this act shall
16	lapse on September 30, 2023."
