A RESOLUTION

Expressing the sincere condolences and sadness of the Twenty-Second Congress of the Federated States of Microensia, to the family of the late President Jacob Nena, at his passing on July 6, 2022 at the age of 80.

- 1 WHEREAS, the late President Jacob Nena served our Nation
- 2 for over 40 years in a long and illustrious government service
- 3 career; and
- WHEREAS, the late President Jacob Nena was a native of the
- 5 State of Kosrae born on October 10, 1941 in Lelu, Kosrae, and
- 6 early in his life he was recognized as a gifted and diligent
- 7 scholar; and
- 8 WHEREAS the late President Jacob Nena graduated from the
- 9 University of Guam with a Bachelor's Degree in Political Science
- 10 in 1971, he went on to earn a Master's Degree in Public
- 11 Administration and Business Management from the University of
- 12 Hawaii (Manoa) in 1972; and,
- 13 WHEREAS, the late President Jacob Nena began his career as
- 14 the Political Affairs Officer for Ponape District from July 1969
- 15 to December 1969, then in 1970 he became the Deputy District
- 16 Representative for Kosrae and served in that capacity until
- 17 1977; and
- 18 WHEREAS, during his many years of service on behalf of the
- 19 people of Kosrae the late President Jacob Nena was very well

- 1 respected by his colleagues and citizens, and was elected as the
- 2 first Governor for the State of Kosrae (1979-1983);
- 3 WHEREAS, as Governor he devoted himself to building and
- 4 defining the new state executive branch, ensuring each
- 5 department and agency was properly established and working, the
- 6 late President Jacob Nena also served as a member of the
- 7 Micronesian Political Status and Transition Commission from 1979
- 8 to 1981, and took part in many of the instrumental decisions
- 9 affecting the transformation to a sovereign nation; and
- 10 WHEREAS, the late President Jacob Nena was elected to the
- 11 Fifth Congress of the Federated States of Micronesia where he
- 12 served with distinction on the Committees for Health, Education
- 13 and Social Affairs, Judicial and Governmental Operations, and
- 14 External Affairs; and
- WHEREAS, following his reelection to the Sixth Congress he
- 16 served as chairman of the Health, Education and Social Affairs
- 17 Committee, and it is through his leadership and hard work our
- 18 Nation continued to develop and mature; and
- 19 WHERAS, recognized for his diverse skills, expertise and
- 20 knowledge in governance the late President Jacob Nena was again
- 21 elected to serve in the Congress of the Federated States of
- 22 Micronesia, and was then selected to be the Vice President of
- 23 the Federated States of Micronesia under President Bailey Olter
- 24 in 1991; and
- 25 WHEREAS, the late President Jacob Nena served as a strong

1 leader in this role until 1996 when President Olter became incapacitated, shortly serving as an Acting President the late 3 President was then sworn in and served as our Nation's fourth president from May 8, 1997 to May 11, 1999; and 5 WHEREAS, with his extensive experience the late President Jacob Nena seamlessly continued to guide our Nation forward contributing not only to our development but to the growth and 8 well-being of the whole Pacific region; now, therefore, BE IT RESOLVED by the Twenty-Second Congress of the 9 Federated States of Micronesia, Fifth Special Session, 2022, that the Congress hereby expresses its sincere condolences and 11 sadness to the family of the late President Jacob Nena at his 12 13 passing on July 6, 2022 at the age of 80; and 14 15 16 17 18 19 20 21 22 23 24 25
