- 12 currently the Charge d' Affairs in the Permanent Mission to the
- 13 United Nations in New York; and
- 14 WHEREAS, Mr. Lippwe represented the FSM Government in many
- 15 foreign affairs matters for over two decades; and
- 16 WHEREAS, Mr. Lippwe served as Minister at the FSM
- 17 permanent Mission since 1999 and was Deputy Assistant Secretary
- 18 for Multilateral Affairs from 1992 up to 1999; and
- 19 WHEREAS, Mr. Lippwe possesses the essential qualifications
- 20 that make him a suitable candidate to serve as the FSM
