Approving and accepting a grant in the amount of \$110,870 from the U.S. Department of Health and Human Services, Health Resources and Service Administration, for the Maternal and Child Health Services Block Grant to the States, to fund the FSM Maternal and Child Health Services for the first quarter of the budget period October 1, 2022 to September 30, 2024, including all the terms and conditions of the assistance.
