

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 17 funds, or so much thereof as may be necessary, are used solely for

incurred in excess of the sum appropriated. The allottee of the funds appropriated under section 1 of this act shall be the Governor of Chuuk State or his designee. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 2024. 6 Section 3.
