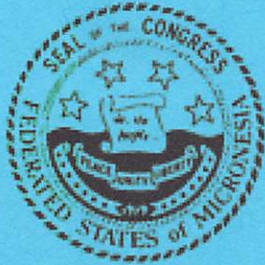

TWENTY-SECOND CONGRESS OF THE FEDERATED STATES OF MICRONESIA

FOURTH SPECIAL SESSION, 2022

CONGRESSIONAL BILL NO. 22-155

AN ACT

To appropriate the sum of \$12,729, from the General Fund of the Federated States of Micronesia from fiscal year ending September 30, 2022, for the purpose of funding public projects and social programs for the people of Chuuk state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$12,729, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia from fiscal year ending September
4 30, 2022, for the purpose of funding public projects and social
5 programs for the people of Chuuk state. The funds appropriated
6 under this section shall be apportioned as follows:

7	(1) State of Chuuk.....	12,729
8	(1) At Large.....	12,729
9	(a) Siis Municipal Government subsidy....	4,000
10	(b) Eot Municipal Government subsidy	5,602
11	(c) Fananu Municipal Government subsidy..	3,127

12 Section 2. Allotment and management of funds and lapse date.
13 All funds appropriated by this act shall be allotted, managed,
14 administered and accounted for in accordance with applicable laws,
15 including, but not limited to, the Financial Management Act of
16 1979. The allottee shall be responsible for ensuring that these
17 funds, or so much thereof as may be necessary, are used solely for
18 the purpose specified in this act, and that no obligations are

1 incurred in excess of the sum appropriated. The allottee of the
2 funds appropriated under section 1 of this act shall be the
3 Governor of Chuuk State or his designee. The authority of the
4 allottee to obligate funds appropriated by this act shall lapse on
5 September 30, 2024.

6 Section 3. This act shall become law upon approval by the
7 President of the Federated States of Micronesia or upon its
8 becoming law without such approval.
