

### AN ACT

To further amend Public Law No. 19-124, as amended by Public Laws Nos. 19-133, 19-140, 19-150, 20-05, 20-15, 20-33, 20-48, 20-63, 20-71, 20-156, 20-175, 21-22, 21-52, 21-146, 21-195, 21-213, 21-244 and 22-62, by amending section 6 thereof, to change the lapse date of certain funds previously appropriated therein, to fund priority infrastructure projects and other programs in each of the states, and for other purposes.

# BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 19-124, as amended
- 2 by Public Laws Nos. 19-133, 19-140, 20-05, 20-15, 20-33, 20-48,
- 3 20-63, 20-156, 21-22, 21-146, 21-195 and 21-244, is hereby further
- 4 amended to read as follows:

"Section 6. Allotment and management of funds and 5 lapse date. All funds appropriated by this act shall 6 be allotted, managed, administered and accounted for 7 8 in accordance with applicable laws, including, but not limited to, the Financial Management Act of 1979. 9 allottee shall be responsible for ensuring that these 10 funds, or so much thereof as may be necessary, are 11 used solely for the purpose specified in this act, and 12 13 that no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated 14 under section 2 of this act shall be the Governor of 15 16 the State of Yap or his designee. The allottee of the funds appropriated under sections 3 and 4 of this act 17

appropriated under subsection 4(3)(al) of this act
shall be the Meninkeder Lapalap of Madolenihmw
Municipal Government or his designee. The allottee of

funds appropriated under subsections 5(1)(2) and
5(1)(7) of this act shall be the Governor of Chuuk
State or his designee; the allottee of funds
appropriated under subsection 5(1)(3) of this act
shall be the Mortlock Islands Development Authority
(MIDA); the allottee of funds appropriated under
subsections $5(1)(1)$ and $5(1)(4)$ of this act shall be
the Mayor of Weno Municipal Government or his
designee; EXCEPT THAT the allottee of funds
appropriated under subsection 5(1)(m) of this act
shall be the FSM Telecommunication Corporation; the
allottee of funds appropriated under subsection
5(1)(5) of this act shall be the Southern Namoneas
Development Authority (SNDA); the allottee of funds
appropriated under subsection 5(1)(6) of this act
shall be the Faichuk Development Authority. The
authority of the allottee to obligate funds
appropriated by this act shall lapse on September 30,
2024."
